Sealed bids will be received until **2:00 p.m. on Monday, January 25, 2016**, by the City of Martinsville Police Department to purchase (2) Two, 2015 or current year 4WD Chevrolet Tahoe Police Pursuit Vehicles, to be used as Canine Units, as per the enclosed specifications. Sealed bids will be received in the office of the Purchasing Manager, Karen Mays, Central Warehouse, 990 Fishel Street in Martinsville, Va. 24112-3248. Bids also may be mailed or sent by FedEx, UPS to the Fishel Street address. Place "Police Pursuit Tahoes" on the lower left hand corner of the envelope and bid due date of 1/25/16 2:00 p.m.

It is the responsibility of the offeror to ensure that their proposal reach the appropriate office prior to the close time on the bid. Response received after the date and closing will be considered non-responsive. Bids will not be accepted via fax machine or internet e-mail.

Quote F.O.B. Martinsville, Va. Freight Prepaid and Allowed.

The Doors will be White. The Hood, Fenders and Rear Quarter Panels are Black. Vinyl wrap, if available, will be purchased.

The Purchase of these two (2) Tahoe's will be contingent upon the City of Martinsville Police Department receiving a grant. Therefore, purchase is not guaranteed.

The City Police Department has chosen the Chevrolet Tahoe as the vehicle of choice. The Chevrolet Tahoe is pursuit rated and will accommodate the K-9 kennel equipment that is stored in the rear of the vehicle. The K-9 kennel that fits the Tahoe provides more area for the K-9 as well as equipment storage in the rear.

#### **4 WD Chevrolet Tahoe Police Pursuit Vehicles**

**This specification is for 2015 or most current model year, Chevrolet Tahoe 4 WD Police Pursuit Vehicles.** The vehicles shall be the manufacturer's "Police Pursuit Patrol" model as indicated and shall meet all requirements of these minimum specifications. The product shall exhibit exceptional handling, performance, stability and maneuverability at both normal and high speeds.

35	Noise Suppression	The vehicle must operate at all speeds with no harmful interference to the performance of the installed public safety equipment (that includes radar, radar detector detectors, lidar, commercial voice and data wireless, 802.11, Bluetooth, mobile computer, GPS receiver, license plate reader, camera system, wireless microphone, wireless video, and private land mobile radios). A patrol vehicle may have a radar on various frequencies, commercial wireless voice and data, high-band VHF (150-173 MHz) and low band VHF (39-46 MHz) 700 MHz band (716-806 MHz) and 800 MHz band (806-854 MHz) two-way radios installed. The vehicle's performance or operation must not be degraded due to the operation of the 125 watt transmitters along with all the other transmitters operating simultaneously. The public safety receivers may not be operationally degraded due to electro-	

magnetic or radio frequency emission from the vehicle. The mfg warranties Electromagnetic Interference (EMI) and Electromagnetic Compatibility (EMC) for a period of at least three years.

Noise Suppression components in the vehicles' electrical subsystems shall be original equipment from the mfg. and not aftermarket. The vehicle must be compatible with the Commonwealth's Statewide Radio (STARS) system with no interference.

The City reserves the right to accept or reject any and all bids, to waive any informalities, and to award this bid as determined to be in the best interest of the City. Again, this purchase is contingent upon receiving a grant and purchase is not guaranteed.

## **NEGOTIATION**

**In the event the bid from the lowest responsible bidder exceeds available funds, the City may negotiate with the apparent low bidder to obtain a contract price within available funds. The procedures for such negotiations shall be as follows:**

**a. City, Engineer, and apparent low bidder together will review the project and attempt to find mutually agreeable proposed changes that will effectively reduce the cost of the project.**

**b. Apparent low bidder will present reasonably documented and substantiated proposed deductions in project cost for each potential project change, which will allow City to evaluate each proposed deduction.**

**c. The parties will attempt to negotiate and sign a reasonable contract for the entire project, the price of which does not exceed available funds.**
