RESOLUTION

AUTHORIZING A LOCAL OFFICIAL TO EXECUTE AGREEMENTS WITH THE VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT) AND ACKNOWLEDGMENT OF LOCAL FUNDING COMMITMENT AS REQUIRED IN VDOT FUNDING AGREEMENTS

WHEREAS, the City of Martinsville desires to have and maintain a safe and efficient road system; and,

WHEREAS, from time to time the City of Martinsville and the Virginia Department of Transportation (VDOT) work together to enhance the transportation system; and,

WHEREAS, certain agreements between the City of Martinsville and VDOT must be executed for this cooperative work to be accomplished.

THEREFORE, BE IT RESOLVED, that the Council of the City of Martinsville does hereby authorize the City Manager to execute agreements, and any modifications to such agreements, with VDOT as needed to advance transportation projects; and,

BE IT FURTHER RESOLVED, that the Council of the City of Martinsville does hereby commit to fund its local share of preliminary engineering, right of way, and construction (as applicable) of the project(s) under agreement with the Virginia Department of Transportation in accordance with the project agreement(s) financial documents.
